I have been an intermittent member of MASTF since June of 1996. While on that committee I, with the help of MASTF, persuaded the METRO Board to banish smoking at all METRO transit centers and at all bus stops in the county. Most recently, as part of that persuasion, NO SMOKING signs have been painted on the pavement at the transit centers and a recent addition to HEADWAYS indicates that it is a violation of Section 640 of the California Penal Code to smoke at those spots designated by the METRO Board. I have been disabled since 1975 because of allergies and am currently retired. I have a BSEE from Cal Poly, San Luis Obispo and was President of the Senior Class when I graduated. I first moved to Santa Cruz County in 1977 and have lived here since, except for 3 years in Nashville, TN from 1981 to 1984. I have used the Transit System for most of that time and am well acquainted with its pluses and minuses. I am interested in serving as MASTF's representative to E/D/TAC because I am sincerely interested in the problems faced by the disabled community and am especially concerned about their problems in trying to articulate those problems to the general public and to governing bodies.
