#### 6. Fiscal Transportation Development Act (TDA) Audits of the SCMTD and the Consolidated Transportation Services Agency

Executive Director Linda Wilshusen said that, in response to Commissioner Keogh's request at the January Regional Transportation Commission meeting, financial audits for two Transportation Development Act (TDA) claimants, Community Bridges and SCMTD, were provided for the Commission to review in anticipation of the Public Hearing on paratransit issues and potential solutions scheduled for February 5, 2004.

Commissioner Beautz asked how much TDA funding was expended on overhead and how much for transit.

Deputy Director Pat Dellin said that this information could be specified as part of the claim request when the TDA claimants ask for their funding.

Executive Director Wilshusen referred to a section of the TDA budget that indicated about 14% was allocated to overhead for Community Bridges. Ms. Wilshusen will verify the information.

Commissioner Keogh thanked staff for the information presented and said it was a good start towards analyzing how TDA funds were spend and would help with TDA claims next spring.

#### 7. Update on State Budget Actions Related to Transportation

Executive Director Linda Wilshusen said that the funding situation in Sacramento did not seem to be getting better and referred to a list of local projects that had state money lapsing in June.

Commissioner Spence noted that some of the projects on the list were completed and it appeared that there was funding left over.

Director Wilshusen said that they were included on the list in the event that there was a final billing still outstanding.

Deputy Director Dellin said that the projects were included to show how the Commission is working with local agencies to fund local projects. Ms. Dellin said that these and other projects depend on many funding sources and are in various stages of completion. With the state budget crisis causing an ever changing environment, it can be complicated and time consuming to get every bit of available money from the various sources.

Commissioner Beautz questioned a statement saying that the SCMTD "should be" reimbursed for their new busses. Les White, SCMTD General Manager, said that they had received the reimbursement and that the approval had come within 4 hours of the deadline. He credited Caltrans and especially Charles Sanchez and Dave Murray for the successful reimbursement. Staff noted that the comment referenced was made prior to the resolution of payment.

Commissioner Keogh asked about the status of the Broadway/Brommer bike path and Commissioner Kennedy said it was moving forward.
