A RESOLUTION APPROVING THE PROPOSED FY 2005-06 ARTICLE 8(c) CLAIM
FROM THE CITY OF SANTA CRUZ ON BEHALF OF COMMUNITY
BRIDGES/CONSOLIDATED TRANSPORTATION SERVICES AGENCY

WHEREAS the Transportation Development Act (TDA) of 1971
provides that the applicant may file an Article 8(c) claim from the
Local Transportation Fund; and

WHEREAS the Regional Transportation Commission, in adopting
its FY 2005-06 TDA budget, has allocated \$557,808 to be used by the
Consolidated Transportation Services Agency for providing
specialized transportation; and

WHEREAS the Elderly & Disabled Transportation Advisory
Committee, at their May 10, 2005 meeting, recommended that the
Regional Transportation Commission approve this claim; and

WHEREAS the City of Santa Cruz is eligible to claim Article
8(c) funds and has, by resolution, agreed on April 26, 2005 to act
as the claimant for Community Bridges/Consolidated Transportation
Services Agency;

BE IT RESOLVED BY THE SANTA CRUZ COUNTY REGIONAL TRANSPORTATION
COMMISSION:

1. A claim submitted in the amount of \$557,808 is consistent with
the Commission budget and would fulfill the requirements as
specified in the act and the Rules and Regulation of the
Commission.
2. The Commission finds that this claim fulfills the
requirements specified in the Transportation Development Act
and the Rules and Regulations of the Commission, as follows:
 - a. The claim includes a proposed budget for the 2005/06 fiscal
year.

- b. The claim includes a statement of projected or estimated revenues and expenditures for the prior fiscal year.
 - c. The proposed expenditure of the funds is consistent with the Regional Transportation Plan.
3. The City of Santa Cruz will act as a claimant on behalf of Community Bridges/Consolidated Transportation Services Agency, for Article 8(c) claims for specialized transportation programs. A claim is hereby approved in the amount of \$557,808 consisting of quarterly payments in the amount of \$211,967 for the first quarter and \$115,280 for the subsequent quarters, subject to the availability of tax revenues.
