A RESOLUTION APPROVING THE AMENDED
TRANSPORTATION DEVELOPMENT ACT ARTICLE 4 CLAIM
FROM THE SANTA CRUZ METROPOLITAN TRANSIT DISTRICT
FOR TRANSIT OPERATIONS FOR THE 2005/06 FISCAL YEAR

WHEREAS, the Transportation Development Act (TDA) of 1971, Article 4, Section 99260(a) of the Public Utilities Code provides that transit operators may file an Article 4 claim for monies from the County's local transportation fund with the transportation planning agency for the County; and

WHEREAS, the Santa Cruz Metropolitan Transit District (SCMTD) is a transit operator in accordance with Article 1, Section 99210 of the Public Utilities Code, and the Santa Cruz County Regional Transportation Commission is the transportation planning agency for Santa Cruz County, in accordance with Article 1, Section 99214 of the Public Utilities Code; and

WHEREAS, the Commission approved a fiscal year 05/06 budget in February 2005 with a total of \$7,587,000 in TDA funds and an apportionment of those funds to SCMTD of \$5,677,686; and

WHEREAS, in May 2005, the Commission approved SCMTD's claim for \$5,677,686 in TDA funds; and

WHEREAS, the Commission amended its fiscal year 2005/06 budget and the Transportation Development Act (TDA) apportionment budget in November 2005 to \$7,649,926 of which an additional amount of \$62,926 was apportioned to SCMTD as a one-time special allocation of surplus TDA funds to be used for transit operations; and

WHEREAS, the SCMTD has submitted an amended TDA claim to include the additional \$62,926 in TDA funds:

BE IT RESOLVED BY THE SANTA CRUZ COUNTY REGIONAL TRANSPORTATION COMMISSION:

1. The Commission finds that this amended claim fulfills the requirements specified in the Transportation Development Act and the Rules and Regulations of the Commission;
2. The amended Transportation Development Act Article 4 claim from the Santa Cruz Metropolitan Transit District for fiscal year 2005/06 is hereby approved in the amount of \$5,740,612.
