A RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR
TO DIRECTLY COMPENSATE MTC SAFE SELECTED TOW TRUCK CONTRACTORS
FOR BACK-UP FREEWAY SERVICE PATROL SERVICES PROVIDED FOR THE SANTA
CRUZ COUNTY FREEWAY SERVICE PATROL PROGRAM

WHEREAS, the Freeway Service Patrol on Highway 1 and Highway 17 is
a heavily used benefit for Santa Cruz County motorists; and

WHEREAS, Metropolitan Transportation Commission Service Authority
for Freeways and Expressways (MTC SAFE) and Santa Cruz County
Regional Transportation Commission Service Authority for Freeway
Emergencies (SCCRTC SAFE) will enter into a new Cooperative
Agreement for management of the Santa Cruz County Freeway Service
Patrol program;

WHEREAS, MTC SAFE retains a fleet of seven back-up trucks to
provide continued level of service when the assigned FSP tow truck
is non-operable;

WHEREAS, MTC SAFE will assign back-up service for SCCRTC SAFE beats
and oversee the procedure for requesting back-up service; and

WHEREAS, MTC SAFE requests that SCCRTC SAFE compensate back-up
service FSP tow truck contractors directly for providing back-up
service on Santa Cruz County Beats,

THEREFORE, BE IT RESOLVED BY THE SANTA CRUZ COUNTY REGIONAL
TRANSPORTATION COMMISSION THAT:

1. The Executive Director is hereby authorized to directly
compensate back up FSP tow truck contractors assigned by the
Metropolitan Transportation Commission Service Authority for
Freeway Emergencies (MTC SAFE) at the rate set by MTC SAFE
including the high and low fuel adjustment rates and
including incidentals as indicated in Exhibit A and/ or
updated Exhibit A as established and maintained by MTC SAFE.
2. The Executive Director is hereby authorized to enter into and
amend any agreements if necessary to achieve Item 1.
