Enclosed are the FY 2008 Transportation Development Act (TDA) and State Transit Assistance (STA) claims of the Santa Cruz Metropolitan Transit District. These funds will be used for transit operations (TDA) and capital (STA) assistance as budgeted in the District's FY 2008 Budget.

The District requests a total of \$12,243,279 in the funds allocated by the Commission on a quarterly basis as shown in the accompanying disbursement schedule. Allocations from these funding categories are listed below:

1. Transportation Development Act – Transit Operations (Article 4, Section A)	\$6,362,037
2. State Transit Assistance Fund – Transit Capital	\$5,881,242
Total	<u>\$12,243,279</u>

The District recognizes that TDA and STA funding levels may change upon adoption of the FY 2008 California State budget. If this happens, an amended claim will be submitted.

The FY 2008 TDA/STA claim includes a justification and demonstrated compliance with the State requirements for the operating revenue ratio and expenditure limitations for the use of these funds, the CHP fleet inspection certification, annual budgets for FY 2007 and FY 2008 and the authorizing resolutions.
