A RESOLUTION APPROVING THE
TRANSPORTATION DEVELOPMENT ACT ARTICLE 4 CLAIM
FROM THE SANTA CRUZ METROPOLITAN TRANSIT DISTRICT
FOR TRANSIT OPERATIONS FOR THE 2007/08 FISCAL YEAR

WHEREAS, the Transportation Development Act of 1971, Article 4, Section 99260(a) of the Public Utilities Code provides that transit operators may file an Article 4 claim for monies from the County's local transportation fund with the transportation planning agency for the County; and

WHEREAS, the Santa Cruz Metropolitan Transit District is a transit operator in accordance with Article 1, Section 99210 of the Public Utilities Code, and the Santa Cruz County Regional Transportation Commission is the transportation planning agency for Santa Cruz County, in accordance with Article 1, Section 99214 of the Public Utilities Code; and

WHEREAS, the Commission has adopted a Transportation Development Act (TDA) budget of \$8,469,000 in its fiscal year 2007/08 budget, and the Commission has apportioned a total of \$6,362,037 to the Santa Cruz Metropolitan Transit District; and

WHEREAS, the Santa Cruz Metropolitan Transit District has submitted a claim for Transportation Development Act funds in the amount of \$6,362,037:

BE IT RESOLVED BY THE SANTA CRUZ COUNTY REGIONAL TRANSPORTATION COMMISSION:

1. The Commission finds that this claim fulfills the requirements specified in the Transportation Development Act and the Rules and Regulations of the Commission, as follows:
 - a. The transit district provides transportation services to the general public.
 - b. The claim includes a proposed budget for the 2007/08 fiscal year.
 - c. The claim includes a statement identifying and substantiating the reason or need for any increase in operating budget in excess of 15 percent above the preceding year or any substantial increase or decrease in scope of operations or any capital budget provisions for major new facilities (Section 99266).
 - d. The claim includes a statement of projected or estimated revenues and expenditures for the prior fiscal year.

- e. The level of passenger fares and charges is sufficient to enable the transit district to meet the fare revenue requirements of Public Utilities Code Section 99268.1 or 99268.2(b) as an older operator.
 - f. The proposed expenditure of the funds is in conformity with the Regional Transportation Plan.
2. The Transportation Development Act Article 4 claim from the Santa Cruz Metropolitan Transit District for fiscal year 2007/08 is hereby approved in the amount of \$6,362,037 to be paid in quarterly payments of \$1,590,509.
 3. An amended claim shall be submitted by the Santa Cruz Metropolitan Transit District should the Commission amend the FY 2007/08 Transportation Development Act Article 4 allocation.
